Up to 30 Boats per Flight**

Total Entry fee \$140 per Team (Entry \$110 **PLUS** \$30 Big Fish Pool). 75% Payback, after expenses, to 20% of field. 1<sup>st</sup> place 15% minimum to 20% maximum of payback. 95% payback of Big Fish Pool to minimum of three (3) places; limited to one big fish per Team and a \$300 maximum. Pay Off computed on number of boats on cut-off date. Blast-off in order of registration number. Mailed entries with full entry fee must be received no later than April 8, 2018. Registration ***will be accepted as cash only*** at the Lake. ***Please call if you will be requesting registration at the lake.*** Teams will receive necessary documents and information by return mail. **\*\*Note:** a Quagga Mussel inspection will be performed.

Entry Forms only accepted through Post Office Box.
